LIFETIME LIMITED WARRANTY

LIMITATIONS ON THE TRANSFERABILITY OF THIS WARRANTY ARE SET FORTH HEREIN.

LIFETIME LIMITED WARRANTY

Owens Corning warrants to the original consumer purchaser ("Consumer") and the first transferee that the SunSuites® Sunroom components manufactured and furnished by Owens Corning listed below shall be free from manufacturing defects. The warranty period commences upon completion of the SunSuites® Sunroom installation. In addition to purchasing a SunSuites® Sunroom from Owens Corning, the consumer must also complete and return to Owens Corning the Lifetime Limited Warranty Registration Card that is attached to this form within ninety (90) days from the date of installation.

- Windows
- Doors

- Decking (Polydeck if applicable.)

TRANSFERABILITY OF THE WARRANTY

This warranty is transferable one time as provided in this paragraph. In the event that the original Consumer sells the building in which the SunSuites® Sunroom has been installed, this warranty may be transferred to that subsequent purchaser. For such transfer to become effective, however, the attached Warranty Transfer Card must be completed and returned to Owens Corning within thirty (30) days of the date of the sale of the building, along with a transfer fee of fifty dollars (\$50.00), payable to Owens Corning.

REMEDY

Should the SunSuites® Sunroom be other than as warranted during the applicable warranty period Owens Corning, at its sole option, will repair or replace the defective components of the SunSuites® Sunroom as well as any other component which must also be repaired or replaced in order to properly repair or replace the defective components. Owens Corning's obligation to pay, however, shall be subject to these limits:

Maximum repair or replacement cost to Owens Corning shall be the replacement cost of the defective components and shall not include any labor charges.

The remedy described above or, at the option of Owens Corning, its monetary equivalent will be the only remedy available to the Consumer for defective components of the SunSuites® Sunroom.

LIMITATIONS ON COVERAGE

This warranty does not apply to, and Owens Corning shall not be liable for, any claims based on or arising from:

The SunSuites® Sunroom being or having been subject to abnormal conditions, including exposure to chemical fumes, vibrations, or abuse to the product itself.

Components of a SunSuites® Sunroom and/or labor not provided by Owens Corning; Causes beyond normal use including, but not limited to: Acts of God, fire, flood, exposure to chemicals, physical abuse or misuse;

Alterations made after completion of installation. Any cause other than manufacturing defects in the SunSuites® Sunroom Components.

ANY IMPLIED WARRANTY, INCLUDING WARRANTY OF FITNESS FOR A PARTICULAR USE OR PURPOSE, AND WARRANTY OF MERCHANTABILITY, IS LIMITED IN DURATION TO THE EXPRESS WARRANTY PROVIDED HEREIN UNLESS A SHORTER PERIOD IS PERMITTED BY LAW. OWENS CORNING SHALL NOT BE LIABLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES OR FOR DAMAGE TO THE BUILDING, ITS CONTENTS OR ITS OCCUPANTS. THIS WARRANTY CONTAINS ALL OF THE PROVISIONS OF YOUR REMEDIES FROM OWENS CORNING. OWENS CORNING'S LIABILITY IS LIMITED TO THE PROVISIONS OF THIS WARRANTY, WHETHER ANY CLAIM AGAINST IT IS BASED UPON STRICT LIABILITY, NEGLIGENCE, BREACH OF WARRANTY OR ANY OTHER THEORY OF CAUSE OF ACTION.

Some states do not allow limitations of how long an implied warranty lasts or the exclusion of incidental or consequential damage so the above limitations or exclusions may not apply to you.

NOTIFICATION OF CLAIMS

Claims pursuant to this warranty must be submitted in writing, together with proof of purchase and installation date, to Owens Corning World Headquarters, One Owens Corning Parkway—Customer Response Center, Toledo, Ohio 43659 within 30 days after discovery of the alleged defect. Within 30 days after receipt of the Consumer's written claim, an Owens Corning representative will contact the Consumer to investigate the claim. This warranty certificate signed by the contractor or dealer and dated as of completion of installation will help establish proof of purchase.
